Call to Order and Roll Call

The regular meeting of the Vancouver City Council was called to order at 6:30 p.m. by Mayor McEnerny-Ogle. This meeting was conducted as a hybrid meeting, including both in person and remotely over video conference.

Consent Agenda (Items 1-7)

WALK-ON ITEM: Temporary Moratorium of 6 Months Upon the Acceptance and Processing of Applications for Permits of Large Warehouse and Distribution Facilities.

Mayor McEnery-Ogle noted staff had requested Council consider the addition of a walk-on item to the Consent Agenda regarding a Temporary Moratorium of 6 months upon the acceptance and processing of applications for permits of large warehouse and distribution facilities.

Motion by Councilmember Fox, seconded by Councilmember Harless, and carried unanimously to amend the Consent Agenda to add the Temporary Moratorium of Large Warehouses and Distribution Facilities.

Motion by Councilmember Fox, seconded by Councilmember Harless, and

carried unanimously to approve 1-4, 6 and 7 of the Consent Agenda. Councilmembers Stober and Paulsen were absent.

Council pulled item 5 from the agenda to return on December 19, 2022, as a first reading of the Ordinances.

1. Continued use of C-101091: WA State DES Contract 03920 for purchasing Freightliner cab and chassis. Manufacture specific parts and services also included

Staff Report: 201-22

Over the lifespan of this contract, seven pieces of equipment that have a Freightliner cab and chassis as its foundation will be due for replacement. This contract also provides price discounts for parts and services needed for maintenance and repairs. Since these purchases will exceed the current contract's \$300,000 spending threshold, we are proactively asking that this contract be amended for purchases to be made according to the departments' current authorized budget in place of setting a new spending threshold. In keeping with Fleet Service's effort to streamline the City's fleet, staff is requesting the ability to purchase from this contract and take advantage of the contract pricing.

Request: Authorize the City Manager or their designee to approve purchases under C-101091: WA State DES Contract 03920 for the life of the contact with Gordon Truck Centers up to the current authorized budget.

2. One Year Health Insurance Stop Loss Policy with Voya

Staff Report: 202-22

City staff worked with its broker, Davidson Benefits Planning, to seek stop loss coverage for its self-insured health benefits program. Stop loss coverage protects the City against catastrophic or unpredictable losses that exceed the City's health care coverage. Voya was the successful bidder with competitive renewal terms. Council approval is needed to provide payment on the premium for the policy.

The individual deductible included in the renewed policy remains at \$275,000. The City's self-insurance covers eligible claims below that threshold. The aggregate reimbursement maximum per policy period included in the insurance is \$2 million. The stop loss insurance covers prescription coverage as well as vision coverage.

Request: Authorize the payment of premiums to Voya for Stop Loss

coverage.

3. Approval of Requests for Paid Time Off (PTO) Cash-out

Staff Report: 203-22

Employees of the City of Vancouver accrue Paid Time Off (PTO) in accordance with City policy or their applicable Collective Bargaining Agreement as a benefit of employment. The City's leave policies assist in attracting and retaining exceptionally talented staff. Relative Union contracts do not have PTO cash-out provisions in their respective contracts. Based on the City's financial position at the end of the year, the City makes determination of whether to afford this opportunity to the Union employees on a one-time basis. Approval of PTO cash-outs does not create a precedent and is viewed by both parties as a one-time opportunity. There is an MOU between the City and the labor groups confirming this understanding. If recommended, the City will bring the PTO cash out requests from these Union groups forward as a single claim voucher request once per year. Doing so has ensured the City's compliance with guidance from the Internal Revenue Service (IRS).

In 2022, the City is recommending to allow for PTO cash-outs to be approved for the respective Union employees. The City's financial position is sound at the end of 2022. Employee PTO banks represent a future liability that the City has the capacity to pay down today, at present day values, in the amounts requested. Approving the requested PTO cash outs at present day values is, therefore, consistent with the City's commitment to 'pay as we go' with sound financial stewardship.

Request: Approve Cash Out of the PTO hours specified in the 2022 PTO Cashout Spreadsheet attached to the staff report concurrent with approval of payment vouchers.

4. Award of grant funds from the Public, Education, and Government Capital Support Fund

Staff Report: 204-22

A RESOLUTION relating to cable television and to the award of Public, Educational and Governmental ("PEG") capital contribution funds to The Vancouver Educational Telecommunications Consortium ("TV ETC") and Clark Vancouver Television ("CVTV") respectively, the designated educational

and government access providers for the City of Vancouver.

The franchise agreements between the City of Vancouver, Clark County and Comcast Corporation provide for a capital contribution in the amount of \$1/month per subscriber for support of Public, Education, and Government (PEG) access and monthly transport costs for public I-NET users. This contribution may only be awarded to designated access providers and iNET users.

The Vancouver Educational Telecommunications Consortium (“TV ETC”), the Designated Access Provider for Education and Clark/Vancouver Television (“CVTV”), the Designated Access Provider for Government submitted applications for PEG capital support funds under the requirements established by the City/County Telecommunications Commission (“Commission”). In total, twelve proposals were received totaling \$588,587.47. Estimated funds available for distribution in 2023 are approximately \$600,000. The grant applications were reviewed by outside technical experts and the PEG Committee, a subcommittee of the Commission.

The Telecommunications Commission through Resolution 2022-003 (attached) recommends that Vancouver City Council award PEG Capital Support Funding as follows:

(Note: Under the terms of the Interlocal agreement between the City and the County, both Councils must approve the grants for funds to be awarded.)

Staff Report: 205-22

AN ORDINANCE relating to zoning for the City of Vancouver and Vancouver Municipal Code (VMC) Title 20; amending the Vancouver Comprehensive Plan and Zoning map designation for adjacent tax lots 158901000, 604757000, and 159762000, located in the City of Vancouver, Clark County, Washington at 5204 and 5206 NE 94th Avenue, and 9309 NE 52nd Street respectively; providing for severability; and providing for an effective date.

AN ORDINANCE relating to zoning for the City of Vancouver and Vancouver Municipal Code (VMC) Title 20; amending the Vancouver Comprehensive Plan and Zoning map designation for tax lot 37910411 located in the City of Vancouver, Clark County, Washington at 301 S. Lieser Road; providing for severability; and providing for an effective date.

AN ORDINANCE relating to Comprehensive Plan and Zoning for the City of Vancouver and Vancouver Municipal Code (VMC) Title 20; amending Appendix E the Vancouver Comprehensive Plan 2011-2030, and VMC 20.130, 20.140, 20.150, 20.180, 20.285, 20.320, 20.430, 20.450, 20.503, 20.570, 20.670, 20.710, 20.790, 20.860, 20.885, 20.920, 20.927, 20.950, 20.960, and 20.970; providing for severability; and establishing an effective date.

The following are proposed:

Map Change – Stutesman – Commercial/CG to Urban High Density/R-22 on 0.8 acres in the Vancouver Mall Neighborhood. Intended to allow future townhome development. Planning Commission recommended approval with 90-day effective period to allow additional time for existing mobile home residents to relocate.

Map Change - Schwartz – Urban Low Density/R-2 to Community Commercial/CC on 2.1 acres on 1st Street near the City of Camas border. Intended to allow expansion of an existing home business. Planning Commission recommended denial by 3-2 vote based on concerns that commercial zoning within residential area might hinder efficient redevelopment of adjacent large lot residences, would make future higher density residential options less likely, and is premature given the pending Comprehensive Plan update.

Map Change - Lieser School Redevelopment - Urban Low Density/R-6 to Urban High Density/R-30 on 8.4 acres in the Vancouver Heights neighborhood. Intended to allow a larger school site redevelopment including a fire station, park, approximately 10 townhomes and 100 affordable rental housing units, and an Educational Opportunities for Children and Families (EOCF) early childhood development facility with childcare, offices, and a commercial kitchen.

Text Change - Evergreen, Camas, and Battle Ground School District Capital Facilities Plans - Adoption of the three District Capital Facilities

Plans by reference into the City Comprehensive Plan, and adoption of associated School Impact Fees in VMC 20.915.060-1:

13. *Correct cross reference in Airport Height Overlay under VMC 20.570.*
14. *Correct outdated reference to Community and Economic Development Department Director in various Title 20 locations.*
15. *Correct Vancouver Lake Greenway map under VMC Figure 20.450-2 to reflect previously approved zoning map change.*
16. *Eliminate reference to outdated C-Tran document under VMC 20.430.030-1 footnote 8.*
17. *Update Planning, Engineering and Fire fees under VMC 20.180.060, 20.180.070, and 20.180.080 to eliminate outdated January 2022 fee listings, clarify language for tenant improvements, and separate out*

ROW permits for residential and commercial uses. Per City code, these were not reviewed by the Planning Commission. Annual CPI-based increases will be applied in 2023.

Request: On December 12, 2022 approve Ordinance A (Stutesman Map Change), Ordinance B (Lieser School Map Change), and Ordinance C (Text Changes), setting date of second reading and public hearing for December 19, 2022.

6. 2022 Second Supplemental Budget

Staff Report: 206-22

AN ORDINANCE relating to the 2021-2022 Biennial Budget and making various appropriations in various funds; declaring an emergency.

The second supplemental of 2022 includes mostly administrative items, such as accounting true-ups and dissolution of several funds that are no longer needed. The 2022 Fall supplemental impacts will have no impact on the 2023-2024 Biennial budget, in accordance with state law. The unexpended appropriation will expire at the end of 2021-2022, unless carried forward via a subsequent 2023 supplemental budget action.

The recommended expenditure appropriation increases for the City's Operating and Capital funds included in the 2022 Second Supplemental Budget totals \$25 million. This represents an increase in appropriation in the operating budget of \$24.7 million, and an increase in the Capital budget of \$0.3 million. The net impact on all City resources is decrease of \$15.9 million in City resources.

The total Operating budget appropriation change in the General, Street and Fire funds represents an increase of \$1.44 million. The remaining \$23.24 million increase relates to changes in other operating funds.

Adjustments to the General, Street and Fire funds include an increase of \$0.8 million in the Fire fund to cover the estimated cost of the PTO cash-out, fuel cost increase impact and cost allocation budget true-up. The additional \$0.5 million appropriation increase in the Street fund represents the impact of the recent Development Agreement with one of the property owners on the Waterfront, resulting in \$0.5 million funding for one of the Streets projects in the downtown area.

The remaining appropriation increase relates to changes in other operating City funds. Major changes are summarized below:

- *An increase of \$4.8 million in the Water utility fund to accommodate the increase in utility revenues to allow for a true-up of the utility tax appropriation. This appropriation is fully covered by increased revenues.*
- *Increase of \$4.9 million in the Risk fund appropriation to adjust for an increase in property and liability claims of \$4.2 million, \$0.5 million increase in the cost of City's insurance premiums and \$0.2 for other minor adjustments.*
- *Additional budget appropriation for the anticipated projects costs funded by the Affordable Housing property tax of \$4.5 million.*
- *Increase of \$3.4 million in the appropriations in the various Park Impact fees resulting from consolidation of funds from old districts (2, 3, 4, 6, 7) to the new districts (A, B, C). This is in accordance with the Council direction to close the old districts funds. These are backed by cash balances in those funds.*
- *Additional budget appropriation of \$2 million is added to the School District Impact Fee Fund due to a stronger construction economy than originally budgeted and a potential for higher SIF revenues than anticipated in the budget. This increase is fully offset by the revenue from developers.*
- *Increase of \$2 million in the Fire Equipment Fund, to pay for an early purchase of a fire truck. The vehicle cost will be covered by the new property tax levy revenues in 2023.*

The total net Capital Budget appropriation of \$0.3 million (including internal transfers) is included in the Second Supplemental of 2022. Expenditures by project are outlined in Attachment C to the ordinance. Below is the project being changed in the Supplemental:

- *Parks capital project totaling \$0.3 million for:*
 - *True-up of project: Ida Bell Jones Park to be funded with parks impact fees.*

WALK-ON - Temporary Moratorium of 6 Months Upon the Acceptance and Processing of Applications for Permits of Large Warehouse and Distribution Facilities

Request: Approve the Ordinance declaring an emergency and impose a temporary moratorium for the duration of six months upon the acceptance and processing of applications for permits for the development or expansion of large warehouse and distribution facilities totaling more than 100,000 square feet under the Warehouse/Freight Movement use classification in the Light Industrial (IL) and Heavy Industrial (IH) zoning districts, as defined in Vancouver Municipal Code Title 20 or as otherwise allowed, such as by prior development agreement, based on certain findings of fact justifying this action and adopted by City Council, and establishing an immediate effective date.

The WALK-ON Item for a Temporary Moratorium of Warehouse and Distribution Centers was discussed directly following the Community Forum. This provided the community an opportunity for public testimony during the Community Forum.

Bryan Snodgrass, Principal Planner, provided an overview of the Moratorium of Warehouse and Distribution Centers.

Council discussed the Item with staff.

Motion by Councilmember Harless, seconded by Councilmember Stober, and carried 4-2 to approve Ordinance M-4396. Councilmembers Hansen and Fox voted No.
